條 款 Terms and Conditions

- 1. 参加者要負責明白自己的身體狀況及健康是否適合是次活動。

Applicants will not be allowed to change their entry to others or to refund their entry fee or part thereof when their application is submitted. (Please enclose a stamped envelope for an official receipt.)

- 3. 本會建議參加者自行安排保險之事宜。本會不會負責任何意外及其它損失或賠償。 The Council suggests that applicants must have their own insurance covers. The Council shall not be responsible for any loss or injury to any applicant or third party in such event.
- 4. 本會有絕對權力決定接受或拒絕任何申請,而不須作任何解釋。
 The Council reserves its rights to accept or reject any application without giving any explanation(s).

- 8. 若活動集合前二小時,天文台懸掛雷暴或雷雨警告訊號、黃色暴雨戒備訊號、紅色暴雨警告 訊號、三號或以下颱風訊號,是次活動將依天氣情況,由活動負責人決定該活動是否繼續進 行,如收不到任何通知,參加者需依照原定時間、地點集合。

Event In-charges decide to continue an event if Typhoon Signal no.3 or below is hoisted and Yellow/Red Rainstorm and Storm Warning is issued <u>two</u> hours before the event begins. Applicants should attend the event if no further information is received.
